COURSE DESCRIPTION:

Using a process consisting of lectures, demonstrations of applied methods and techniques, and application of skills and problem-solving practice, the student will prepare for the California State Board of Barbering and Cosmetology licensure exam and a career in one or more of the cosmetology professions. The curriculum consists of 1600 clock hours covering all phases of cosmetology, esthetics and manicuring, concurring with guidelines issued by the state. Students work on mannequins and clients to develop practical experience utilizing safe practices in a salon setting.

COURSE PREREQUISITES:

A potential student must be 16 years of age to begin training and 17 before the licensure exam and must have completed 10th grade or passed a G.E.D. that meets California standards.

Students should be competent in English at a minimum level in order to successfully complete the course of study. Those students who do not pass the entry level English test, will be recommended to con-currently take English as a Second Language on site or as a home study course.

GOALS:

After completing the course, a student will be prepared to pass the licensure examination and possess entry level skills for employment as a cosmetologist.

PERFORMANCE OBJECTIVES:

By the completion of the 1600 hours and all modules in the course, a student will demonstrate knowledge of, proficiency in, and practical problem solving skills in the following modules:

Hair Shaping and Design

Specific proficiencies are listed in each module of the course outline.

INSTRUCTIONAL STRATEGIES:

Supervised, small group instruction and individual attention are combined with continuously rotating modules to allow a student to begin classes at any time throughout the year without interruption to other students and without missing any module segments. Attendance hours are flexed so that the student has options to insure maximum opportunity for progress at the student's own pace.

- 1. Technical instruction refers to demonstration, lecture, class participation or examination; applied effort refers to the actual performance of a complete activity on a client or mannequin.
- 2. Small group, individual interaction and student mentors are important components in student comprehension of key elements within each segment.
- 3. A full video library of lectures and demonstrations on module segments are available for students to review procedures and prepare for the state exam.
- 4. Practical experience is gained through supervised practice of skills and application of knowledge during problem solving on actual clients.

EVALUATION:

Student progress is evaluated by observation of technical procedure applications, and written oral examination of specific criteria mandated by the Board of Barbering and Cosmetology.

- 1. Each student receives an entry assessment of reading and listening comprehension to identify remedial needs with language.
- 2. A student must pass written and oral tests with a minimum score of 75% accuracy upon completion of each module segment or review and retake the exam.
- 3. A student must demonstrate a skill level equal to that needed to pass the state exam according to the California Cosmetology Criteria or retrain in that module and retake the exam.
- 4. A student will receive a certificate of achievement upon meeting course requirements for completion.

REPETITION:

The course is state mandated to be completed within 1600 hours of attendance. If a student has not completed the minimum amount of hours in technical and operations of applied effort, he/she must continue until everything has been completed.

CREDITS:

Credit is given for competency demonstrated at a semi-skilled level of successful training. Credit may be earned at one credit per 15 hours of successful training. Course completion equals 106 earned credits

UNITS OF INSTRUCTION:

Cosmetology is dynamic and changes as knowledge in new chemical processes expands and fashion and styling techniques emerge. The time spent on these modules may vary as each increases or decreases in relevance to the field.

Foundational theory, technical demonstrations and applied practice are usually integrated within module topics.
